## CLYDE MARINE PLANNING PARTNERSHIP AND CLYDE 2020

The ongoing process of forming “The Clyde Regional Marine Plan” has moved forward in the past year with the draft plan expected to be passed to Marine Scotland in the coming few months which will pave the way for the plan being taken through a public consultation later in the year. Following the consultation the “Plan” will be updated before being presented to the minister for approval. The public consultation process is the chance for Sea Anglers to voice their opinions alongside other stakeholders and members of the public.

The Clyde 2020 Steering Group which is part of the Clyde Marine Planning Partnership has now been existence for 5 years which gives you an idea of how slow the process of marine planning moves – having sat through many meetings during this period I can say that I feel very frustrated in the lack of progress. That being said this is the first time that representatives of from local councils, the commercial fishing sector, Marine Scotland as well as conservation organisations such as the COAST (Community of Arran Seabed Trust), SIFT (Sustainable Inshore Fisheries Trust), The RSPB, Environment Link (A coalition of conservation organisations) and SSACN representing recreational sea anglers have sat round the table to try and find a way forward.

## Blue Fin Tuna

Over the last few years the interest the sightings of Blue Fin Tuna in Scottish Waters has been increasing significantly. The main sightings in Scottish waters have occurred of the west coast of Harris in the Outer Hebrides and have been recorded by Angus Campbell of Kilda Cruises (there have been other sightings elsewhere too).

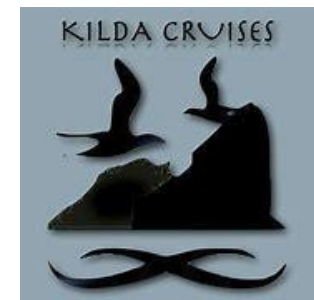
Angus is a keen angler and has been keen to get a recreational Blue Fin Tuna fishery in operation. However there is currently no quota available to the U.K to allow this fishery to be opened. Therefore for the last year Angus has been involved in scientific tagging of Tuna which aims to give scientists a better understanding of the numbers of Blue Fin Tuna in Scottish waters and their migration patterns. I attended one of these trips last year to assist with the work and learn a bit more about the study and despite seeing large numbers of tuna up to 400lb right beside the boat, we never caught one to tag.

This year the Harris Development Trust in conjunction with Marine Scotland are hoping to take this work a step further by conducting a full socio-economic study which may support a future recommendation to open a recreational Blue Fin Tuna fishery in Scotland. The Federation will be supporting this work in any way it can and I personally intend to be heavily involved in assisting with this study. I understand there will be some information required from anglers and I will be in touch with the membership once I have further details.

The Federation continue to support the “Sea Angling Diary”- The Sea Angling Diary Project is for UK sea anglers to help improve the sustainable management of marine stocks and demonstrate the value of sea angling. The project is delivered by Substance and the Centre for Environment, Fisheries and Aquaculture Science (Cefas) on behalf of all the UK governments and devolved administrations. It helps report the activity, catches and value of recreational sea angling to assist better informed decision making. **Extract from SNH Website - An online resource for tracking the movements of some of the largest and rarest creatures in British waters has been expanded.**

The Skatespotter website, which includes details of 1,500 critically endangered common or flapper skate, has been updated to include historic records that give an improved insight into the lives of individual fish over time. The refresh was announced as Scotland’s Year of Coasts and Waters 2020 gets underway. Anglers are encouraged to submit any photographs of common skate they catch and release to the database, allowing researchers working to conserve the species to identify individual fish by the distinctive spot patterns on their backs and study their movements.

For the first time, historic information from the Scottish Shark Tagging Programme (SSTP) dating back to 1975 has been added, as well as additional tagging data and photographs from Orkney, Shetland, the Outer Hebrides and Portpatrick.
